Arrangement of Electronic Dissemination of Corporate Communications

All future Notice of Publication will be deemed to have been duly received by you and the Company will be considered to have been duly discharged of and released from its obligations thereof if the Company has sent such Notice of Publication to the email address provided by you via the Intermediaries without receiving any message or indication of non-delivery.
